We are pleased to announce our upcoming conference on Chemical Management on May 27th. In our training programs on sustainable chemical management with Chinese textile and shoes supply chain factories in cooperation with German brands and retailers, including Zalando, several tools and training materials have been developed. These toolkits shall be introduced together with a range of other comprehensive industry approaches and multi-stakeholder initiatives, for example Zero Discharge of Hazardous Chemicals (ZDHC) or the German Partnership for Sustainable Textiles (PST).

As part of our event, we will provide you specific breakout sessions on different chemical management topics to ensure engagement and exchange with and among our participants.
